BILL OF SALE OF WATER LINE

WHEREAS, the undersigned desires to obtain water service from the Gonzales County Water Supply Corporation, hereinafter referred to as "GCWSC", and has made application therefore and has signed the necessary membership application documents; and

WHEREAS, GCWSC does not have any water lines in the immediate area of the point at which the undersigned has made application to take service, and the GCWSC has no money immediately available to install water lines to service the area in which the undersigned has requested water service; and

WHEREAS, the undersigned has agreed to pay all cost of installing the water line, fittings, valves, and all other materials and equipment necessary to extend water service from the existing lines of the GCWSC to the point at which the undersigned has requested the water line service; and

WHEREAS, the GCWSC has agreed to provide water service to the undersigned at the normal and usual water rates and to maintain said water line in exchange for the conveyance by the undersigned to GCWSC of the water line and the control thereof, fittings, valves, and all other materials installed and paid for by the undersigned:

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that _____, of the County of _____ and the State of _____, for and in consideration of the sum of one dollar (\$1.00), to the undersigned in hand paid by GCWSC, the receipt of which is hereby acknowledged, and the further consideration by GCWSC to maintain and repair the hereinafter referred water line and all appurtenances thereto, have Bargained, Sold, and Delivered, and by these do Bargain, Sell, and Deliver unto the said Gonzales County Water Supply Corporation, of the County of Gonzales, and State of Texas, the following described property:

It is acknowledged that the Grantor herein relinquishes all rights and control of said water line, valves, appurtenances to said Gonzales County Water Supply Corporation.
